# ❖ Current Status of CNGOs and ANGOs



By 2019, GPP received **239 applications**



By 2019, GPP provided **99 Certificates to 68 CNGOs**



By 2019, there are **many Applicant NGOs** are fulfilling the recommendations from NCCC

# ❖ Transitional period between the current and new GPP Standard

When the new GPP modality to be commenced in 2021, CNGOs under the old system will choose one among the two proposals:



- Upgrade to the new modality (3ys plus 2ys) and GPP team will assess their compliance capacity to the new requirements
- Continue with existing 3ys validity with 2 times compliance monitoring

For the current applicant NGOs have to apply the new modality when they are ready

## ❖ Implementation plan of the new GPP modality

- Conduct mobilization, sensitization recruitment and orientation of new members of merged WG and NCCC.
- Restructure GPP team and recruit additional staff as necessary (Assessment Team and Capacity development team)
- Conduct capacity assessment of GPP team against skills needed to manage the new modality (outsource)
- Procure IT company to digitize the new Modality (including training of users)
- Continue to conduct the compliance monitoring with existing CNGOs

# ❖ Implementation plan of new GPP modality

- Develop new GPP modality assessment tools
- Conduct the GPP promotional workshops
- Provide presentation of New GPP modality to individual NGOs
- Select the volunteer NGOs to test the new assessment tools
- Provide capacity building to volunteer NGOs
- Call for GPP community member in early 2021.

- Have a governing body with at least three members



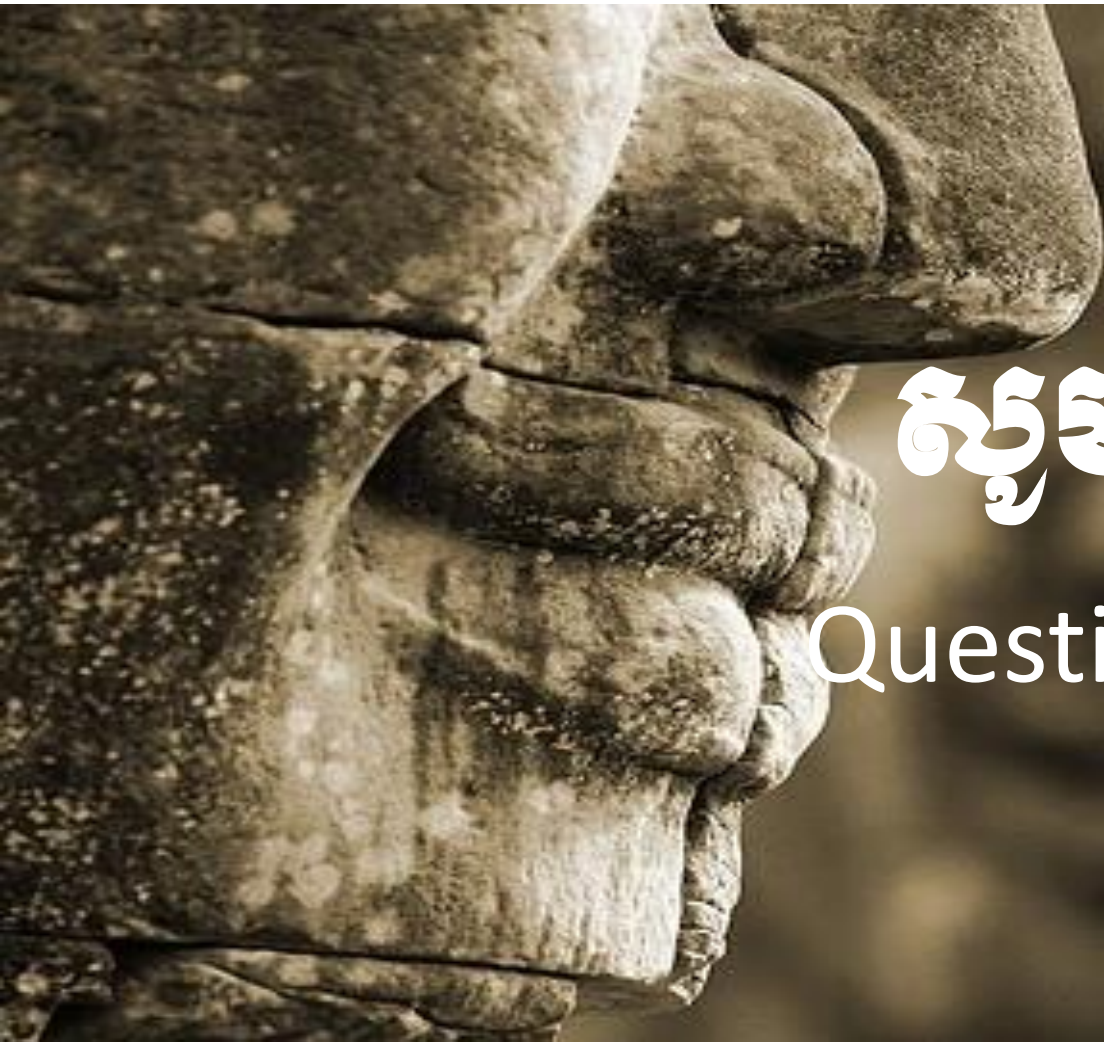


- Learnt the standard that could strengthen the CSOs accountability and transparency like the Governance and Professional Practices Standards, the Global Standards for CSOs Accountability
