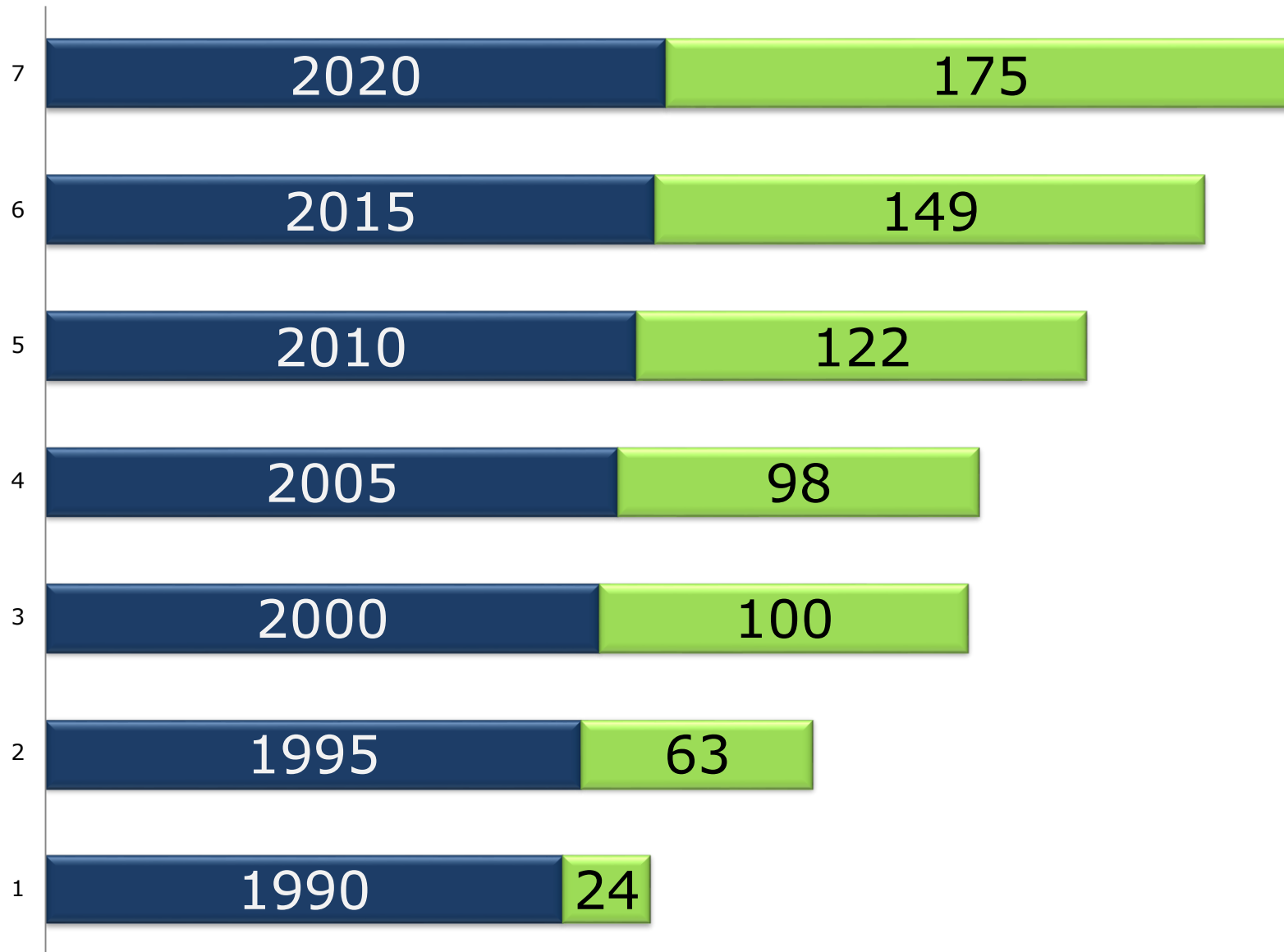

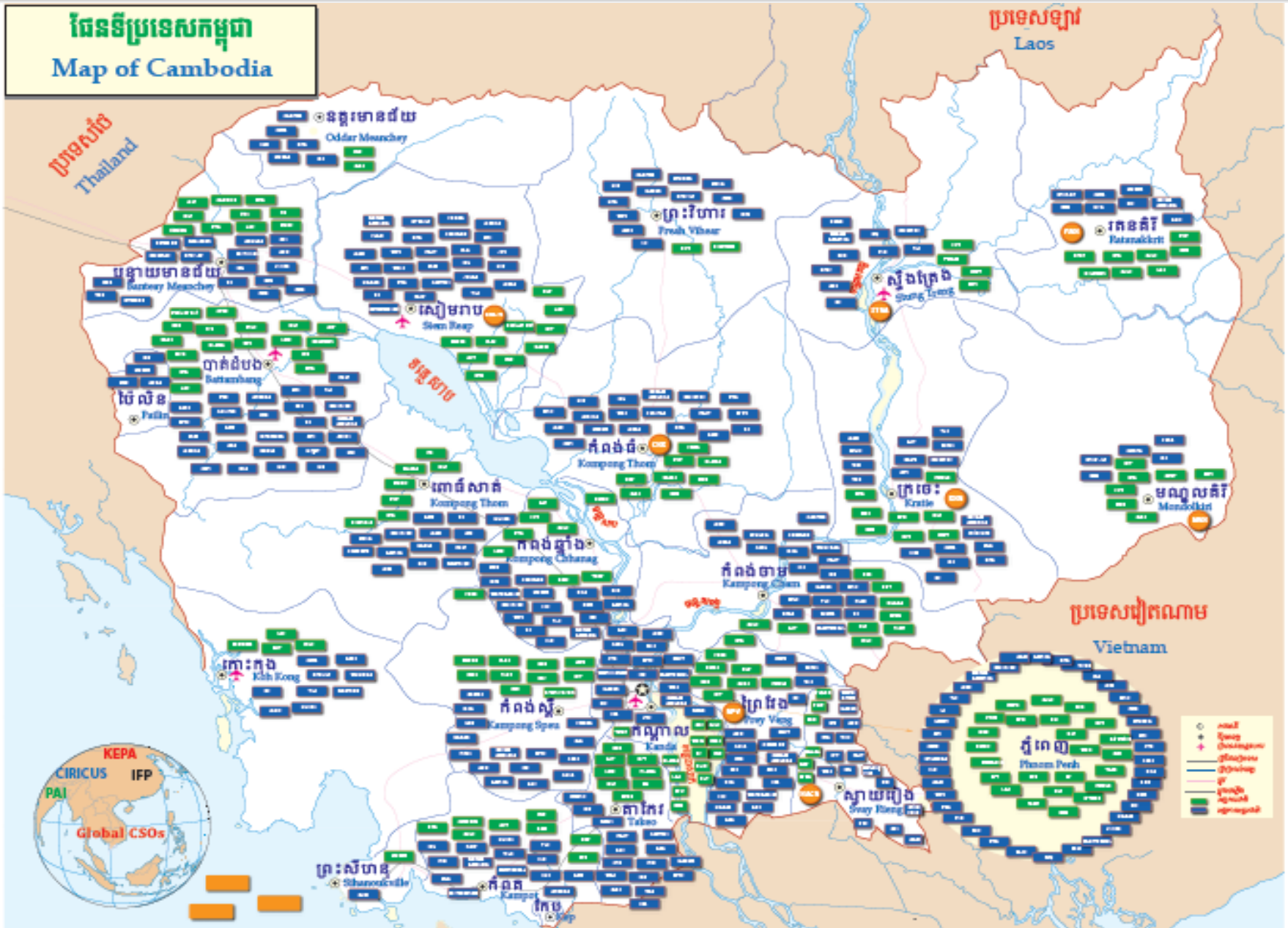
Increase of CCC Members 1990–2020



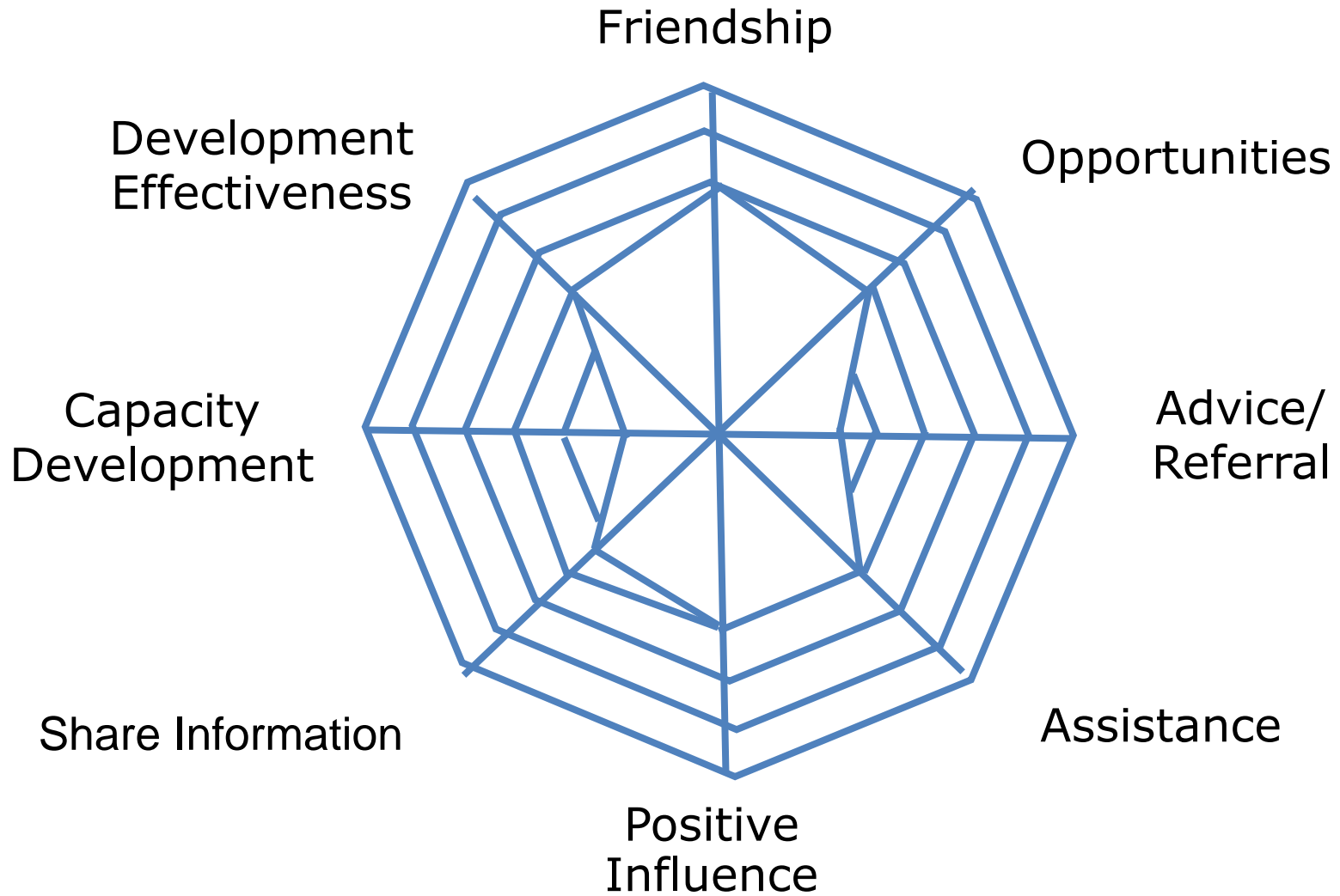
